Each of the undersigned, in consideration of Innisvale granting to the undersigned the right to witness the foregoing cremation, and for other good and valuable consideration (the receipt and sufficiency whereof are hereby irrevocably acknowledged), does hereby remise, release and forever discharge Innisvale, its employees, agents, directors, officers, and shareholders of and from all manner of actions, causes of action, deeds, suits, proceedings, claims, demands, damages (known or unknown), sums of money, actions, grievances, and liabilities whatsoever, both in law and in equity, which against Innisvale, its employees, agents, directors, officers and shareholders, the undersigned ever had, now has or hereafter can, shall or may have for or by reason of or in respect of any cause, act, matter or thing whatsoever, in connection the foregoing cremation.

Each of the undersigned further covenants and agrees not to join, assist, aid or act in concert in any manner whatsoever with any other person, firm or corporation in making of any claim or demand or in the bringing of any proceedings or action in any manner whatsoever against Innisvale, its employees, agents, directors, officers and shareholders, and not to make any claim or demand nor bring any proceedings or action in any manner whatsoever against any person, firm or corporation who might claim contribution or indemnity from Innisvale, its employees, agents, directors, officers and shareholders, arising out of or in relation to the matters hereinbefore remised, released or discharged.
